Certificate Programs Leading to Designations

Most CampusMBA certificate and designation programs are composed of three levels. The first two levels — the achievement certificate and professional certificate — lay the foundation for the final level, the specialist designation.

These certificate programs are listed in the chart at right (read the chart from left to right to see the overall program as it leads to a specialist designation).

It is not necessary to complete the entire path of a program. Many professionals, as well as organizations, seek certification via CampusMBA programs, but do not choose to progress to the designation level.
